

Terms of Service

Effective Date: [12.02.2026]

Welcome to UNLOQ SHARING, a mobile application that provides electric scooter rental services (hereinafter referred to as the “App”, “we”, “our”, or “us”). By downloading, accessing, or using our App and services, you agree to comply with these Terms of Service (“Terms”).

Please read them carefully.

1. Eligibility

To use UNLOQ SHARING, you must:

- Be at least 16 years old.
- Have a valid driver's license (if required by local regulations).
- Agree to these Terms and our Privacy Policy.
- Have a registered user account in the App.

2. User Account and Verification

- You are responsible for maintaining the confidentiality of your account credentials.
- You agree to provide accurate, complete, and up-to-date information.
- We reserve the right to suspend or delete accounts that are fraudulent or in violation of the law or these Terms.

3. Rental Use and Obligations

When renting a scooter:

- You must follow all local traffic and road safety laws.
- You are fully responsible for the scooter during your rental session.
- You must return the scooter to a valid parking zone as defined by the App.
- You agree not to:
 - o Ride under the influence of alcohol or drugs.
 - o Carry passengers or use the scooter for commercial purposes.
 - o Damage, modify, or tamper with the scooter.

4. Payments and Fees

- All rental fees, pricing, and charges are displayed in the App.
- Payment must be made via the supported in-app payment systems.
- Additional fees may apply for:
 - o Late returns
 - o Improper parking
 - o Damages
- We reserve the right to change pricing at any time with notice through the App.

5. Liability and Insurance

- You ride at your own risk. UNLOQ SHARING is not liable for any injuries or property damage caused by improper or unlawful scooter use.
- In case of an accident, theft, or damage, you must immediately notify UNLOQ SHARING via the App and local authorities if required.
- You may be held liable for repair costs if damage results from negligence.

6. Termination and Suspension

We may suspend or terminate your access to the App and services if:

- You violate these Terms or applicable law.
- You misuse our scooters or App.
- We are legally obligated to do so.

You may delete your account at any time by contacting support.

7. Data Protection

We collect and process personal data in accordance with our Privacy Policy.

We comply with Law No. 6698 on the Protection of Personal Data (KVKK).

8. Modifications

We may update these Terms from time to time. Any changes will be announced through the App. Your continued use of the service after updates constitutes your acceptance of the new Terms.

9. Governing Law

These Terms shall be governed by and construed in accordance with the laws of the Republic of Türkiye.

Any disputes arising from these Terms shall be subject to the jurisdiction of the competent courts of Istanbul (Anatolian).
